What is the Community Advisory Council?

The Community Advisory Council (CAC) is open to all citizens of Howard County and provides feedback, insight, and community views to the Board of Education of Howard County (BOE). We strive to represent a diverse and wide ranging set of viewpoints.

The group facilitates communication between the community and the Board on issues of concern, and inquires about matters concerning education as directed by the BOE.

At monthly meetings, the CAC brings in guest speakers to provide its members with information about initiatives, educational programs and processes. This enables the community to participate more effectively in the educational process and to make the process more responsive to the community.





How Does the CAC Work?

The CAC meets one evening a month.

Information is gathered

 Education-related initiatives, reports, and research findings are presented to the entire group by HCPSS administration and community organizations.

Discussion and feedback

- Everyone is encouraged to ask questions of the guest speakers, to express their thoughts and share comments from themselves and others in the community.
- Votes of consensus are taken when the CAC is prepared to offer opinions or recommendations to the Board or a policy committee.


Recommendations are presented


