- Redistricting Meeting will be held on 10/3/2017

There will be no high school redistricting for 2018–19 under Martirano's proposal. The next high school redistricting process will begin during the 2020–21 school year to prepare for opening High School #13 in fall 2022. The recommendations include JumpStart HCPSS, an initiative to expand dual enrollment options for students at Centennial, Howard and Long Reach high schools.

The proposal includes redistricting 1,922 elementary students to fill Elementary School #42 and bring 37 schools at or below target utilization, providing relief to schools in Columbia and in the eastern and northern parts of the county. Redistricting at the middle school level is proposed to move approximately 300 students to align feeder patterns with the realigned elementary attendance areas.

Interim Superintendent Michael J. Martirano, members of the Board of Education, system leadership and school system staff recently joined approximately 250 community partners for the annual Howard County Public School System Educational Partnerships Celebration at the Sheraton Columbia.

• Manor Woods is a Blue Ribbon School

Manor Woods Elementary School Named 2016–2017 Maryland Blue Ribbon School

The Maryland State Department of Education (MSDE) named Manor Woods Elementary School as one of only six Maryland public schools to receive the State's Blue Ribbon award this year. New Blue Ribbon Schools were recognized on the basis of rigorous standards for high achievement and significant improvement developed by MSDE and the U.S.

The Howard County Public School System accepted public suggestions of names for Elementary School #42, scheduled to open for the 2018-2019 school year. Suggestions were accepted September 20-October 11, 2017.
