- Medication storage boxes have been distributed free; so far they have given out some approx. 2,000
- Please safely store your medication to hide away from kids, you can use fire boxes, safes, other locked cabinets.
- Please don't keep medication in kitchen or bathroom
- Drug Take Back Day held Saturday, Oct. 28<sup>th</sup> in Wilde Lake Village Center collected 1212 pounds of medication. It is held every 6 months on the National Drug Take Back Day (DEA sets dates)
- They also collect sharps! We don't want them in landfill.
- Watch out for ways teens can be keeping drugs vodka in waterbottles, raspberry candy, etc.
