Ms. Silverman's office is available to speak to your school or PTA meetings if you contact them.

Local PTAs and PTACHC have been receiving phishing emails, asking for money. They look as if they are from the president or another PTA member. Make sure the emails are legitimate.

- 1. Hover over the email address to see where they are actually from.
- 2. All payments must be by check only.
- 3. All PTA checks must have 2 signatures.
- 4. Call person it is from to verify request.

#### Legislative

- Donna Sudbrook has accepted the Legislative chair for PTACHC.
- Discussion items:
- 1. APFO- Structuring of fees related to property transactions can affect APFO
- 2. Fees: Building, Excise fee, Transfer tax
- 3. State matching formulas may be changing
- 4. Adjacent counties compared to Howard County; Howard county builders pay less than other counties to build
- 5. Lots of factors affect how much of the funds from properties are provided to schools.
- 6. You need to know the cost to build
  - Fees come from builders, buyers and sellers.
  - Operating costs come from income and property taxes

### **Board of Education Report**

- Governor Hogan wants to legislate a committee to make sure the schools are held accountable.
