Dr. Caroline Walker HCPSS Executive Director of Program Innovation and Student Well-Being and Mr. Bill Barnes, HCPSS Chief Academic Officer

- Program offers the option to earn college credit while in high school.
- Students are enrolled from all 12 high schools
- Classes are taught at all high schools with more options available at Oakland Mills and River Hill.
- 15 students graduated with 30 college classes last year.
- MD state law was passed in 2013 to get more students gain college classes in high school.
- Jump start is also being used to try to relieve some overcrowding.

• Question: What question would you ask state delegation regarding overcrowding?

When development expansion is reviewed, school needs are not considered. This should be included in the Howard County general plan.

Adequate Public Facilities Ordinance Basics (APFO)

- Brent Loveless PTACHC President
- Without PTA members advocating for effective APFO policies, the situation would be worse.
- Most counties in MD have APFO law, so that there are there are proper public facilities (police, education, fire, water, etc.).
- APFO is a regulation in Section 16 of subdivision code of Howard County.

APFO Basics (continued)

- APFO regulates amount and location of growth
- APFO is a key factor in determining if redistricting is needed or when it should occur.
- IAC construction, housing policy, subdivision exemptions, spending affordability, etc. have effect on APFO
- Next APFO review is in 3 4 years
- General Plan is reviewed every 10 years.
- Idea from Christina-Delmont Small:

Have Development Polygons – When a community is built and capacity level is reached, then the entire new development will go to a school in another location.
