Delegate Vanessa Atterbeary:

- sponsoring a bill to change the way school board members are elected.
- Current basic vision screening at HC public schools does not substitute for full eye exam.

Delegate Terri Hill:

discussing proposed bill to make sports safe in schools to find areas of agreement.

Senator Clarence Lam;

- discussed a Maryland bill proposing to undo changes made to 529 education saving accounts by the federal tax overhaul that was adopted 2018.
- Wants to close new benefit of 529 that allows parents to use it for K-12 non-public schools

Delegate Eric Ebersole:

- Co-sponsoring bill with Senator Lam regarding 529 to penalize or tax the use of 529 plans for K-12
- Legislation regarding Superintendent hiring and firing, & termination will be reviewed

Delegate Elect Courtney Watson:

 Discussing whether MD Legislation should introduce legislation to ensure that Howard County Schools do not have to with the current State law that they have to start after Labor Day

Senator Elect Katie Fry Hester:

wants to have more apprenticeships for K-12

Q: Concern to require council not to vote on legislation if it affects realtors/builders who have contributed to their campaign.

A: Tradition of the Howard County Delegation to first list the local HC bills, then discuss statewide bills

Q: Why are we not allowing the use of 529 for K-12?

A: Can still get the tax advantage; will still have the benefit for federal level but just not for state level.

Q: Can early screening for dyslexia be increased?

A: Delegate Terri Hill: there is a bill but not specifically addressing dyslexia; but possibly there is an unpresented bill
