Superintendent's Report: Pat Saunderson reporting. February 18th will be the BoE student representative election.

BOE Report: Jen Mallo reporting. Currently working with next year's budget proposal from Superintendent Martirano, with the next Board budget work session on Thursday, 5 February, and expect to approve a budget for presentation to the County Executive on February 13th. As usual, the request will almost be reduced, and the BoE accepts community input on prioritizing budget items.

MD PTA Report: No report.

PTA Survey Update: Trina Thames reporting. 86 people participated in the online survey on ranking educational concerns that PTACHC should address. Highest concern was increasing the operating budget for education, with school overcrowding being the second highest.

Treasurer's Update: Joe Griffin reporting. There will be audit training at the end of the year. Report of January transactions. Gift card and online payment policy and guidance change is coming from MD PTA, and will be communicated when it's available.

Policy Update: Meg Ricks reporting. BoE meeting on the 13th on school activity funds and non-school curricular activities and take action on teaching controversial issues. March 3rd BoE meeting with PTA Presidents and CAC.

Board of Education Candidates Update: Tonya Tiffany reporting. This year will be the first year where BoE members will be mostly district based with two at-large members, and five by-district members. Primary is April 28th, with 19 candidates, with ten total for the general election (two per district).
